Penelitian ini bertujuan untuk mengetahui Pengelolaan Alokasi Dana Desa (ADD) di Desa Kamuh Kecamatan Tujuh Belas Kabupaten Bengkayan. Teknik pengumpulan data dalam penelitian ini denga observasi, wawancara dan dokumentasi. Hasil penelitian dari Pengelolaan Alokasi Dana (ADD) dengan upaya Pembangunan Desa di Desa Kamuh Kecamatan Tujuh Belas Kabupaten Bengkayang menunjukkan bahwa: A). Tahap Perencanaan Alokasi Dana Desa (ADD) di Desa Kamuh Kecamatan Tujuh Belas Kabupaten Bengkayang sudah mulai menerapkan prinsip Transparansi. B). Pada tahap pelaksanaan Alokasi Dana Desa (AAD) di Desa Kamuh Kecamtan Tujuh Belas Kabupaten Bengkayang telah melakukan swakelola kepada Pemerintah Desa juga perlu meningkatkan kesejahteraan masyarakat. C). Tahap Pertanggungjawaban Alokasi Dana Desa (AAD) Di Desa Kamuh Kecamatan Tujuh Belas Kabupaten Bengkayang, sudah cukup baik dalam teknis maupun administrasi, tapi tetap harus mendapatkan bimbingan dari Pemerintah Kecamatan.

ABSTRACT

This study aims to determine the Management of Village Fund Allocation (VFA/ ADD) in Kamuh Village, Tujuh Belas District, Bengkayan Regency. Data collection techniques in this study were observation, interviews and documentation. The results of the research from the Fund Allocation Management (VFA/ ADD) with Village Development efforts in Kamuh Village, Tujuh Belas District, Bengkayang Regency showed that: A). The Village Fund Allocation (VFA/ADD) planning stage in Kamuh Village, Tujuh Belas District, Bengkayang Regency has begun to apply the principle of transparency. B). At the implementation stage of the Village Fund Allocation (VFA/ AAD) in Kamuh Village, Tujuh Belas District, Bengkayang Regency, the Village Government has carried out self- management to improve the welfare of the community. C). The Village Fund Allocation (VFA/ AAD) accountability stage in Kamuh Village, Tujuh Belas District, Bengkayang Regency was sufficient both in technical and administrative terms, but still needs to get guidance from the District Government.
