

ABSTRAK

Ridho Wibisono: Peran Pemerintah Desa dalam Pengembangan Badan Usaha Milik Desa di Desa Jangkang Dua Kecamatan Kubu Kabuapten Kubu Raya. Skripsi. Pontianak: Program Studi Ilmu Pemerintahan Fakultas Ilmu Sosial dan Ilmu Politik Universitas Tanjungpura.

Penelitian ini bertujuan untuk mendeskripsikan dan menganalisis peran pemerintah desa dalam pengembangan badan usaha milik desa di Desa Jangkang Dua, Kecamatan Kubu, Kabupaten Kubu Raya, Pemerintah Desa Jangkang Dua dilihat dari peran-perannya sebagai regulator, dinamisator dan fasilitator dalam pengembangan badan usaha milik desa Jangkang Dua. Penelitian ini menggunakan pendekatan kualitatif dengan jenis penelitian deskriptif, teknik pengumpulan data dilakukan dengan wawancara. Subjek penelitian ini terdiri dari 3 (tiga) orang dari unsur Pemerintah Desa Jangkang Dua, dan 2 (dua) orang dari unsur Pengelola Badan Usaha Milik Desa Jangkang Dua, serta 2 (dua) orang dari unsur masyarakat desa Jangkang Dua. Berdasarkan hasil penelitian dapat disimpulkan bahwa peran pemerintah desa Jangkang Dua dalam pengembangan badan usaha milik desanya belum optimal, dapat dilihat sebagai berikut: (1) Peran pemerintah desa sebagai regulator yaitu telah menerbitkan berbagai peraturan berskala desa terkait badan usaha milik desa Jangkang Dua; (2) Peran pemerintah desa sebagai dinamisator yaitu kurang intensif dalam melakukan rapat bersama pengelola badan usaha milik desa dan kurang intensif melakukan sosialisasi kepada masyarakat terkait badan usaha milik desa Jangkang Dua; (3) Peran pemerintah desa sebagai fasilitator yaitu belum pernah memberikan pelatihan kepada pengelola badan usaha milik desa, serta belum mampu memfasilitasi kebutuhan badan usaha milik desa Jangkang Dua, Kecamatan Kubu, Kabupaten Kubu Raya.

ABSTRACT

Ridho Wibisono: The Role of the Village Government in Developing the Village-owned Enterprises in Jangkang Dua Village of Kubu District of Kubu Raya Regency. Thesis. Pontianak: Governance Science Study Program of Social and Political Science Faculty of Universitas Tanjungpura.

This study aimed to describe and analyze the role of the village government in developing the Village-owned Enterprises in Jangkang Dua Village, Kubu District, Kubu Raya Regency. The Jangkang Dua Village Government was seen from its roles as regulator, dynamist, and facilitator in developing the Village-owned Enterprises of Jangkang Dua Village. This study used the qualitative approach with a descriptive research design. The technique of data collection used was interviews. The research subjects consisted of 3 (three) persons from the Jangkang Dua Village Government, 2 (two) persons from the Organizer of Village-owned Enterprises of Jangkang Dua Village, and 2 (two) persons from the community of Jangkang Dua Village. The results of this study showed that the roles of the Jangkang Dua Village Government in developing the Village-owned Enterprises were not optimal yet which could be seen from the role of the village government as a regulator which had issued various village-scale regulations related to the Village-owned Enterprises of Jangkang Dua Village, the role of the village government as a dynamist which was less intensive in conducting meetings with the Village-owned Enterprises organizers and less intensive in conducting socialization to the community regarding the Village-owned Enterprises of Jangkang Dua Village, and the role of the village government as a facilitator which had never provided training to the Village-owned Enterprises organizers and had not been able to facilitate the needs of Village-owned Enterprises of Jangkang Dua Village, Kubu District, Kubu Raya Regency.
