

ABSTRAK

Dionisius Rizal: Peran Pemerintah Desa Dalam Pembangunan Desa Rabak Kecamatan Sengah Temila Kabupaten Landak. **Skripsi.** Program Studi Ilmu Administrasi, Jurusan Ilmu Administrasi Publik, Fakultas Ilmu Sosial Dan Ilmu Politik Universitas Tanjungpura Pontianak.

Penelitian ini dilatarbelakangi pembangunan fisik pada rencana kerja Pemerintahan Desa Rabak tahun anggaran 2021 masih banyak yang tertunda. Oleh sebab itu, penelitian ini bertujuan untuk mendeskripsikan dan menganalisis peran Pemerintah Desa Rabak dalam pembangunan fisik pada RKPDDes tahun anggaran 2022. Metode penelitian menggunakan jenis penelitian kualitatif dengan pendekatan deskriptif. Hasil penelitian menggunakan teori peran pemerintah dalam pembangunan oleh Siagian (2020, 142-148) dengan unsur peran selaku stabilisator, pelopor, modernisator, inovator dan pelaksana sendiri. Simpulan dalam penelitian adalah peran Pemerintah Desa Rabak dalam pembangunan fisik. Selaku stabilisator, telah mengkoordinasikan kegiatan pembangunan fisik secara partisipatif. Selaku pelopor dalam penerapan perencanaan, pelaksanaan dan pengawasan pembangunan dengan total kegiatan pembangunan fisik berjumlah 12 dan terealisasikan berjumlah 12. Selaku modernisator, melaksanakan kegiatan bimbingan teknis dengan total kegiatan berjumlah 3 dan terlaksana berjumlah 3. Selaku inovator, telah memperbarui dan meningkatkan pembangunan fisik pada tahap dua dan tahap tiga dengan total kegiatan berjumlah 5 dan terealisasikan berjumlah 5. Selaku pelaksana sendiri dalam pembangunan, Pemerintah Desa Rabak dan unsur masyarakat telah bersama-sama dalam mengelola aset desa yaitu tanah kas milik desa yang dikelola menjadi sawah milik desa dan hasilnya dipergunakan demi kepentinya penyelenggaraan pemerintahan, pembangunan desa dan pelayanan kepada masyarakat Desa Rabak.

ABSTRACT

Dionisius Rizal: The Role Of Village Government In The Development Of Rabak village Of Sengah Temila District Of Landak Regency. **Skripsi.** Public Administration Science Study Program of Social and Political Science Faculty of Universitas Tanjungpura Pontianak.

This study was based on the physical development of the Rabak Village Government workplan for the 2021 fiscal year which was still much delayed. Therefore, this study aimed to describe and analyze the role of Rabak Village Government in the physical development of the Village Government Work Plan for the 2022 fiscal year. This study used the qualitative research design with a descriptive approach. This study used Siagian's theory of government roles in development (2020, 142-148) with elements of the role as a stabilizer, pioneer, modernizer, innovator, and executor. The results of this study concluded that the role of the Rabak Village Government in physical development as a stabilizer had coordinated participatory physical development activities and as a pioneer in implementing development planning, implementation, and supervision with a total of 12 physical development activities and 12 were actualized. As a modernizer, the village government conducted technical guidance activities with a total of 3 activities and 3 were implemented. As an innovator, the village government had updated and improved the physical development of the village in stages with a total of 5 activities and 5 were actualized. As the executor in development, the Rabak Village Government and elements of the community had jointly managed village assets, specifically village treasury land which was managed to become village-owned rice fields and the proceeds were used for the needs of governance, village development, and services to the community of Rabak Village.
