

PERAN NOTARIS DALAM PENGISIAN DATA AKTA PERSEROAN KOMANDITER MELALUI SISTEM ONLINE SINGLE SUBMISSION

ABSTRAK

Notaris adalah pejabat umum yang berwenang dalam membuat akta pendirian Perseroan Komanditer (CV) sebagaimana tercantum didalam Pasal 15 Ayat 1 UUJN. Berkembangnya teknologi, pendaftaran Perseroan Komanditer (CV) dilaksanakan secara *online* melalui sistem *Online Single Submission* (OSS). Adanya pendaftaran Perseroan Komanditer (CV) secara *online* tentu mempermudah dan mempercepat pendaftaran. Namun tidak bagi masyarakat yang berada di daerah sulit internet dan kurangnya pemahaman tentang sistem *Online Single Submission* (OSS).

Rumusan masalah dalam penelitian ini terkait Apakah peran seorang Notaris dalam pelaksanaan pengisian data akta Perseroan Komanditer yang terintegrasi melalui sistem *Online Single Submission* (OSS) serta bagaimana tanggung jawab Notaris dalam pelaksanaan pengisian data akta Perseroan Komanditer yang terintegrasi melalui sistem *Online Single Submission* (OSS). Jenis penelitian dalam penelitian ini menggunakan metode pendekatan yuridis normatif yaitu dengan meneliti bahan kepustakaan, buku-buku serta norma-norma yang terdapat dalam peraturan perundang-undangan. Serta menggunakan teknik pengambilan data melalui teknik komunikasi langsung dengan melakukan wawancara terhadap Notaris.

Kesimpulan dari hasil penelitian bahwa peran seorang Notaris dalam pelaksanaan pengisian data akta Perseroan Komanditer (CV) melalui sistem *Online Single Submission* (OSS) merupakan kuasa yang diberikan secara lisan oleh Pelaku Usaha kepada Notaris untuk membantu Pelaku Usaha, yang mana kuasa secara lisan sah menurut Pasal 1793 KUH Perdata. Tanggung jawab Notaris berdasarkan adanya unsur kesalahan yang dilakukan Notaris yang mana Notaris dapat dikenakan tanggung jawab secara perdata, administratif, maupun tanggung jawab secara pidana apabila mengandung unsur-unsur tindak pidana.

THE ROLE OF NOTARIES IN FILLING THE DATA OF DEEDS FOR LIMITED PARTNERSHIP THROUGH THE SYSTEM ONLINE SINGLE SUBMISSION

ABSTRACT

Notary is a public official who has the authority to make a deed of establishment of a Limited Partnership (CV) as stated in Article 15 Paragraph 1 of Notary Position. With the development of technology, the registration of Limited Partnership (CV) is carried out online through the Online Single Submission (OSS) system. The online registration of Limited Partnership (CV) certainly simplifies and speeds up registration. However, this is not meant for people who live in areas where there is no internet and lack of understanding of the Online Single Submission (OSS) system.

The formulation of the problem in this research was related to the role of Notaries in implementing the filling of data of deeds for Limited Partnership through the integrated Online Single Submission (OSS) system and the responsibility of Notaries in filling of data of deeds for Limited Partnership through the integrated Online Single Submission (OSS) system. The type of research in this research used normative juridical approach, namely by examining library materials, books and norms contained in statutory regulations. In addition, data collection techniques used direct communication techniques by conducting interviews with notaries.

It can be concluded from the research results that the role of Notaries in filling the data of deeds for Limited Partnership (CV) through the Online Single Submission (OSS) system is an authority given orally by the Business Actor to the Notary in order to assist the Business Actor, in which oral authority is valid according to Article 1793 of Civil Code. The notaries' responsibility is based on the element of wrongdoings by the Notaries where they are liable for civil, administrative or criminal liability if it contains elements of a criminal act.
